ORDERING INFORMATION

- Orders will be processed and sent the same day as received. Any delays may be attributed, but not limited to: credit issues, high average order volume, or time of day order is received. Orders with instruments may require additional time for quality control.
- Dealers are encouraged to place music accessories, printed music, and music gift orders together to minimize shipping costs.
- Special Orders: Please allow 3 to 4 weeks—vendors and publishers require this amount of time to fill special orders. Additional time may be required to obtain foreign or print-on-demand publications. Please remind your customers that Special Order items cannot be cancelled or returned.
 - Special Orders are defined as: Any non-stock products.
- No order minimum. Orders are processed immediately, therefore cannot be held for additions to the same order. A new order will be created for additional products.
- When ordering, please provide the Chesbro item number, vendor item number, and/or publisher item number. If the item number is not available, please provide as much information as possible including the complete name of product, and if applicable, title, publisher, composer, arranger, instrument, key, etc. as available.
- Unless otherwise requested, items out of stock will be backordered and shipped when available.
- All orders are shipped UPS unless otherwise specified.

BACKORDERS

- Please allow 3 to 4 weeks for backorders.
- Most backorders cannot be cancelled (i.e. Special Orders).
- If backordered items are in stock the same day another order is placed, Chesbro Music Co. will make every attempt to consolidate the orders to minimize shipping costs.
- Chesbro Music Co. will hold backordered product with a total value less than \$100.00 for a maximum of 10 business days before shipping.
- Backorders totaling more than \$100.00 will be shipped automatically. You may or may not be called concerning backorders due to an automated process. Sorry, no freight/postage credits will be allowed for product shipped in this manner but we will make every effort to ship the most economical method.
- If additional orders are placed during the 10-day period, the backordered product will be consolidated with your other orders and shipped together. Please contact your Customer Service Representative to ship backordered immediately, regardless of value.

RETURNS

- All products should be inspected immediately upon receipt. Any discrepancies or damage must be reported to Chesbro Music Co. within five (5) business days to be considered for return. If shipment is freight damaged, please call Chesbro Music Co. immediately for a UPS claim to be initiated. The claim must be made by Chesbro Music Co. Do not call the freight carrier.
- Chesbro Music Co. accepts returns for defective products due to manufacturer or publisher errors, shipment errors, and damaged products. Please contact your Customer Service Representative to obtain your Return Authorization number (RA#) and instructions for returning product. You must obtain a Return Authorization number for all returns. Mouth blown instruments must be returned to the manufacturer according to Federal Laws.
- Chesbro Music Co. reserves the right to determine the distribution of Return Shipping Tags.
 - Return Shipping Tags are not issued for: Customer owned product, print music, and product weighing less than five (5) pounds.
 - Issued Return Shipping Tags are for the product on the referenced RA only. Using the tag for product not on the RA may result in restocking or shipping fees.
